

Brand New Book ***** Print on Demand *****.Excerpt from The Thirteenth Annual Report of the Windsor Historical Society of Windsor, Connecticut (Incorporated), 1934 Upon continued non-payment of dues for one year without explanation or response to statements the delinquent names shall be reported to the Executive Committee and upon recommendation may be dropped from the roll without notice. Active or Sustaining members not in debt to the Society may become Life members on payment of \$25 at one time. Sustaining members shall be entitled to all publications of the Society free of charge. Article II Officers And Their Duties 1. The officers of the Society shall be elected by ballot at the annual meeting, and shall hold office for one year or until their successors are chosen. There shall be a President, Vice-President, Secretary, Treasurer, Recorder, Assistant Recorder, and an Executive Committee consisting of the regular officers of the Society together with three members who shall be elected at the annual meeting. When a vacancy in any office shall occur during the year the Executive Committee may appoint an incumbent for the unexpired term. 2. The President shall preside at all meetings of the Society, shall be chairman of the Executive Committee and ex-officio member of all Committees of the Society. The Vice-President shall perform the duties of the President in his absence. The Secretary shall keep an accurate record of all meetings, a true list of members and shall receive and answer communications to the Society, and shall perform such other duties as may be delegated by the President or Executive Committee. The Treasurer shall receive records and hold for the Society all deeds, mortgages, notes, and moneys from dues, donations or bequests...
